# Pro-rata fee being charged for 'Repeat/ Missed Practicals' in BCA & MCA from January 2018 session – regarding

- **1.** Revised programme fee has been made effective from January 2018 admission cycle as per letter.No.IG/SRD/R-I/RevisedFee/2017/689 dated 04/10/2017 issued by Registrar, SRD. Accordingly, **Prorata fee** for re-admission is also being revised (to be made effective from January 2018 session).
- 2. Revised Pro-rata fee for the courses of BCA and MCA finalized by SRD from January 2018 session is given below:

#### BCA (pre-rev. and revised sylb.)

Rs. 400/- per 1 credit course

Rs. 800/- per 2 credit course

Rs. 1200/- per 3 credit course

Rs. 1600/- per 4 credit course

Rs. 2400/- per 6 credit course

Rs. 3200/- per 8 credit course

### MCA (Revised sylb.)

Rs. 1200/- per 2 credit course

Rs. 1800/- per 3 credit course


Rs. 2400/- per 4 credit course

In this connection, your attention is invited to our letter cited above wherein it has been informed that "............ pro-rata fee is to be calculated on the basis of the total fee for the semester divided by the number of courses in that specific semester....."

 Alternatively, RDs can also utilize the pro-rata fee per course fixed for readmission in Computer Programmes, printed copies of which have been recently circulated vide our letter No.IG/SRE-Ex.III/Re-admss/2006/1052 dated 31.03.2006.

Sub: Repeat/missed practical session for Computer Programmes

Dear Sir/Madam,

Enquiries have been received from some Regional Directors about conduct of practical sessions for those students who may have either missed the practical sessions in respective semesters or whose attendance in practical sessions is less than 75% due to which they are not permitted to appear in the term-end practical examinations. Such students may be allowed to do practical sessions by paying 50% prorata fee of the specific course. Pro-rata fee is to be calculated on the basis of the total fee for the semester divided by the number of courses in that specific semester. However, they may be permitted to attend the repeat/missed practicals when the practical sessions of that specific course are conducted during the next semester/session only. Such students may attend practical sessions in the aforesaid semester and need not wait till the completion of all semesters.
